Donors have the option of participating in the <u>Community Trust</u> <u>Fund</u>, where the donors can transfer securities – whether publiclytraded stocks, bonds, or mutual funds – as a gift-in-kind from their brokerage account to a registered charity's brokerage account.

Additionally, members get *discounts* on seminars and events, website creation and design, property and liability insurance, office supplies, and guidance for serving vulnerable people in their communities.

We're constantly in touch with our member charities, and we really enjoy coming up with new ways to offer them the unique resources that will meet their needs so that they can operate well.


